## OPEN LETTER FROM THE FEDERAL LEADER OF THE OPPOSITION CONFIRMING SUPPORT FOR FBT ARRANGEMENTS

NALSPA has welcomed the Federal Leader of the Opposition's confirmation that the existing Fringe Benefits Tax (FBT) framework as it applies to employer-provided motor vehicles (i.e. novated lease arrangements) and all other salary packaging arrangements will be retained under a Bill Shorten led Government, if elected.

A copy of an Open Letter to NALSPA members from the Leader of the Opposition is attached. Such certainty is vital for the numerous sectors to which NALSPA members provide services.

In particular NALSPA notes the Leader of the Opposition's commitment to the Statutory Formula Method (SFM), which provides a simple, low-cost compliance method to determine the taxable value of the private usage of vehicles provided to employees.

These vehicles are used by ordinary working Australians including many nurses, police officers, teachers and charitable workers, as well as many employees of small, medium to large businesses.

Importantly the SFM is a key driver of new car sales, resulting in significant downstream economic benefit for Australia's automotive sector that employs an estimated 230,000 people.

In support of the confirmation from the Leader of the Opposition, NALSPA Chairman Robbie Blau said, "We are pleased that Labor has adopted NALSPA's policy position regarding the FBT treatment of workers' vehicles and salary packaging arrangements more generally, which now aligns both major political parties".

"In removing any uncertainty, we are confident Bill Shorten's decision will continue to benefit our economy, the automotive sector, and employers and employees across the country", Mr. Blau added.
